

Privacy policy for Contacs form

This information is provided pursuant to art. 13 of EU Regulation 679/2016 by the company PLUS COTONE SRL based in Via Nazionale 182/A 40051 Altedo di Malabergo (BO) Italy, as Data Controller for those who access the website of Plus Cotone srl itself and fill out the form "contacts" authorizing the same Plus Cotone srl to the processing of personal data. The provision of data is optional. The refusal to provide data implies the impossibility of processing and following up the requests received.

Purpose of the treatment

The personal data provided by users are used for the sole purpose of processing and following up their requests.

Legal basis

The personal data provided by users are processed lawfully to carry out the execution of pre-contractual measures or contractual obligations (Article 6 paragraph 1 letter b) of Regulation 679/2016), requested by the users themselves (request sent by filling out the form) .

Recipients of the data

Personal data provided by users will in no way be disclosed to third parties. They can be communicated to employees and collaborators of the Owner who will treat them in accordance with the instructions given by the Owner.

Responsible for processing

In case of need, for activities related to the maintenance of the technological part of the site, the personal data provided may be processed by persons in charge of the company Plus Cotone srl appointed responsible for data processing pursuant to art. 28 of the EU Regulation 679/20016.

Data retention

The personal data of users will be processed for the time necessary to fulfill the purposes indicated.

Rights of the interested party

Pursuant to articles 13, paragraph 2, and from 15 to 21 of the Regulations, we inform you that in relation to the processing of your personal data you can exercise the following rights:

a) Right to obtain access to personal data and the following information: - confirmation that the processing of personal data is currently underway; - the purposes of the processing; - the categories of personal data; - the recipients or categories of recipients to whom the personal data have been or will be communicated; - if the data are not collected from the data subject, all the information available on their origin; - the existence of an automated decision-making process, including profiling; - a copy of the personal data being processed.

b) Right of rectification and integration of personal data;

c) Right to delete data ("right to be forgotten") if there is one of the following reasons:

1. Personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed; 2. the interested party revokes the consent to the processing of data and there is no other legal basis for the processing; 3. the interested party opposes the processing and there is no legitimate overriding reason to proceed with the processing; 4. personal data have been processed unlawfully; 5. personal data must be deleted to fulfill a legal obligation under Union or Member State law to which the data controller is subject. If the data controller has made public personal data and is obliged to delete it, he must inform the other owners who process the personal data of the request to delete any link, copy or reproduction of his data.

d) Right to limit the processing in the event that:

1. the interested party contests the accuracy of personal data, for the period necessary for the data controller to verify the accuracy of such personal data; 2. the processing is illegal and the interested party opposes the cancellation of personal data and asks instead that its use is limited;

3. even if the data controller no longer needs it for processing purposes, personal data are necessary for the data subject to ascertain, exercise or defend a right in court; 4. the interested party opposed the processing, pending verification of the possible prevalence of the legitimate reasons of the data controller with respect to those of the interested party.

e) Right to propose a claim to the Guarantor for the protection of personal data, following the procedures and indications published on the official website of the Authority www.garanteprivacy.it.

f) Right to the portability of the data of the interested party or the right to receive, in a structured format, in common and automatic way, the personal data concerning him / her provided to a data controller and possibly transmit them to another data controller, if the treatment is based on consent or on a contract and is carried out by automated means. Where technically possible, the data subject has the right to obtain direct data transmission from one data controller to another.

g) Right to oppose at any time the processing of personal data, including profiling, in particular in the event that: 1. the processing is based on the legitimate interests of the owner, subject to explanation of the grounds of the opposition; 2. Personal data are processed for direct marketing purposes.

h) Right not to be subjected to a decision based solely on automated processing, including profiling, except in cases where the decision is necessary for the conclusion or execution of a contract between the data subject and a data controller, is authorized by the law of the Union or of the Member State to which the controller is subject or based on the explicit consent of the data subject.

i) Right to withdraw consent at any time; the data, if not based on another legal basis (including, fulfillment of a legal obligation or execution of a contract) must be deleted by the holder. The exercise of rights is not subject to any form constraint and is free.
